COMMITTEE CHARGES:

- Implement approved format changes to *JAPR* manuscripts
- Develop and implement Board-approved plans to improve the quality and speed of the review process for *JAPR*, including development of reviewer training program
- Develop and implement education plans for submitting authors to improve first submission manuscript quality, especially focusing on top reasons for rejection of manuscripts.
- Review and provide impact assessment of reduced Open Access fee in conjunction with *PS-EIC*, and *PSA* Executive Director.
- Identify possible papers to be highlighted as a news release for *PSA* (coordinate with the *PSA* Executive Director).

COMMITTEE DUTIES (*Coordinate with PS Editorial Board as appropriate*):

- Work with regional conferences to adopt conference proceedings into invited review articles for *JAPR*.
- Continue to increase pages published and service of journal to members.
- Continue to work on decreasing review times.
- Help to identify international members that can serve as journal paper reviewers.

RELEVANT INFORMATION FROM THE PSA CONSTITUTION:

ARTICLE 10

Committees

Section 3. There shall be Publication Committees for *Poultry Science* and for *The Journal of Applied Poultry Research* each consisting of the Editor-in-Chief and the Section/Subject Editors. The

President, Secretary-Treasurer, and Managing Editor will serve as ex officio members of both Publication Committees.

- (a) The Editors-in-Chief and Section/Subject Editors of *Poultry Science* and *The Journal of Applied Poultry Research* are appointed by the Board of Directors to a three-year term, subject to reappointment for one additional three-year term. Outgoing editors may be appointed to other duties on the Editorial Board the year after their term expires; however, a one-year period must elapse before the editor can be reappointed to the same position. The Associate Editors/Review Board for *Poultry Science* and the Editorial/Review Board for *The Journal of Applied Poultry Research* are appointed by their Publications Committees for three- and one-year terms, respectively.
- (b) The Publication Committees shall have charge of all technical editorial details connected with publication of the journals and newsletter as authorized by the Board of Directors. All business details connected with the publication and sale of the journals and newsletter shall be the responsibility of the Secretary-Treasurer, or the Executive Director, as authorized by the Board of Directors.
